CHRISTIAN THOMAS LEE

"The Art of Philanthropy"

The artistry of Christian Thomas Lee has been enjoyed for over twenty-five years. He has been the guest of some of the most distinguished gatherings in the world to include presidents, royalty, philanthropists and captains of industry. After 1,800 performances and five recordings, he has been given a unique position in the world of the fine arts.

Retiring from the international concert circuit in the mid 1990's following a four month Australasian tour, he has since been recognized for his philanthropic work through the private estate and home concert in the tradition of Franz Schubert's 19th century music salon.

His philanthropic efforts on behalf of nonprofit organizations and his advocacy for children's causes have been widely recognized from the White House to former presidents. In 2006, he was awarded the Point of Light Award in recognition of his national work on behalf of children's causes and also awarded the President's Call to Service Award for his volunteerism. President George H. W. Bush said of Christian, "Your acts of generosity and community action exemplify the spirit of service and set a standard of excellence to which people of all ages can aspire. You are a remarkable example of the generosity and compassion that helps to better our communities. I commend your work and thank you for being a shining point in the lives of the people of America." Christian has consistently leveraged his considerable influence to inspire others to give to those in need. He is a collector of fine art and his personal collection, acquired from Sotheby's and other international auction houses, includes works by Pablo Picasso, Peter Carl Fabergé, Giovanni Battista Pasqualini and Adolf Pirsch. The collection includes old master engravings, impressionist works, American and European historic documents and antiquities. Every year, his personal collection of fine art travels extensively to schools where it is shared with children. Over 75,000 children have experienced Christian's nationally recognized and awardwinning application of Art and History in Schools. He has also been invited to lecture on the subject of creativity in education in numerous universities and colleges including; George Mason University, Marymount University, Texas Tech University, Baylor University, Lubbock Christian University, Houston Baptist University, and Columbia College.

Christian is recognized as a major advocate of philanthropy. Central to his heart and of primary motivation is a compelling desire to make a difference in the world by connecting the powerful with the weak, the rich with the poor, and the educated with the uneducated. RIMA BARKETT

Chef Rima Barkett grew up in Tuscany, Italy, and in her mother's kitchen she learned the love of feeding people. Rima brought those traditions with her to the United States in 1993 when she moved here after marrying Anthony Barkett. In 2006, the Barketts moved with their daughter to Rome to spend a few years working on the World Summit of

Nobel Peace Laureates. She continues to be active in global peace initiatives through her foundation Ambassadors of Peace. Rima's love of cooking and her mother's inspiration has been a main ingredient in the passions she has chosen in her life, including her advocacy for children and those less fortunate.



CINDY BASSO

LODI MEMORIAL HOSPITAL AND FOUNDATION

Outstanding Philanthropic Organization

In 1946 community members were appointed to draw up articles of incorporation for the Lodi Memorial Hospital Association. The association became the non-profit owner of the hospital and was operated by community members for community members. A quiet fund drive of about 500 residents raised \$65,000 followed by 3,500 donors contributing to the hospital campaign. Lodi Memorial Hospital was opened in 1952. In 1980 the Lodi Memorial Hospital Foundation was formed and has raised significant funds for Lodi Memorial Hospital's capital improvements, new technology, and outreach. The LMH Foundation will continue to support Lodi Health, its facilities and services serving the community for years to come.



DIANNE AND GENE GINI *Outstanding Philanthropists*

Native Stocktonians Dianne and Gene Gini epitomize the spirit of philanthropy - generously giving to so many charitable organizations through their company, Collins Electric, and from their personal assets, it's impossible to count.
