The Venue

The mission of the Cedarburg Cultural Center is to provide a gathering place to celebrate community, the arts and local heritage.

For nearly 30 years the Cedarburg Cultural Center, in the heart of historic downtown Cedarburg, has been the cultural hub of our community—the place where art, music and history thrive. From the beginning, the Center has provided access to and participation in the visual and performing arts, the humanities and local heritage. A free gallery with frequently changing exhibits surrounds the Center's performance space, which features music, theatre, comedy and educational presentations. Exhibits include curated shows of artistic and historical interest and juried shows by local artists. Classes are also offered for children and adults. The Center's public spaces may also be rented for events ranging from business meetings to wedding receptions.

The galleries, classrooms, and restrooms of the Cedarburg Cultural Center are wheelchair accessible.

Delivery of Works: In-person delivery: Monday, November 30: 10 am-5 pm
Shipped works should arrive at the Center by November 30 in sturdy, reusable containers. Please, no "popcorn" packing materials. The artist is responsible for the cost of shipping both ways and insurance during transit. Please provide prepaid return shipping labels.
Exhibition Closes: Sunday, January 17: 4 pm
Pick up of unsold works: Tuesday, January 19: 10 am-5 pm.

Entry Fees: Cedarburg Cultural Center Members: \$25, Non-Members: \$35
All fees are payable to the Cedarburg Cultural Center and are non-refundable.

Awards: Best of Show: \$300 and a solo exhibit in one of the CCC's galleries.
Professional Awards: First Place \$200, Second Place \$100

Application Process: Artists should submit three sample images to be juried, representative of the artist's style, genre and craftsmanship. Artist selection will be based on the entire body of work submitted. Work submitted for consideration is not required to be miniature. (Works created for the show will be required to be miniature.) Accepted artists will be asked to deliver five original works in the same style, media and quality as the works submitted for the jury process. The artwork need not be the same pieces as those submitted for jurying. Artwork must be original and not prints or multiples.

Submit your images by email to: Jeanette@ArtMusicHistory.org or on a CD saved as jpegs, no larger than 2 MB. One image per title. Image title must contain your last name and number to correspond with the entry form (ie. smith1.jpg, smith2.jpg, smith3.jpg). Image must be in upright viewing manner. Please check to be sure that your images can be opened. (If you need your CD returned, please provide a SASE with adequate return postage.)

Exhibition & Sale: The Center will retain a commission for all other art sales of 35% for CCC Members and 40% for Non-Members. All work must be priced and available for sale. No price changes or title changes may be made after entry. Following the Preview Party and Awards Ceremony, artworks will be sold "Cash and Carry." Artists will be contacted with the option to bring replacement pieces for sold artworks. Replacement works must adhere to size restrictions noted below.

Requirements: For 2D works: Image size may not exceed 25 square inches. (for example, 5x5" or 3x 8 1/3" Overall size (size including frame dimensions), must not exceed 64 square inches (for example 8 x 8"). 2D works may be in any media and must be ready for display/installation (no sawtooth hangers, please). Works should be clearly labeled on the backside with your full name, address, title of the work, medium and price. All work is required to be available for purchase. For 3D works: works must not exceed 8 inches in any dimension, including the base. Sculptural work must stand firmly on its own if not mounted to a base. Artworks will be checked for adherence to size restrictions. Any works not adhering to size restrictions will be ineligible for cash awards.



Application/ Entry Form: Applications must be postmarked or delivered in person by Friday, September 18, 5 pm. Artwork submitted for jury purposes need not be the same pieces as those submitted for the exhibit. However, all artwork should adhere to the same overall style. Artwork deviating from the overall style of work originally submitted for jurying will not be shown in the exhibit.
