### What data do we collect?

- Personal identification information (Name, email address, phone number, etc.)

### How do we collect your data?

You directly provide AsiaChanRose.co.uk with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

### How will we use your data?

- Email you with news and event updates about Asia Chan-Rose that you might like.

### How do we store your data?

AsiaChanRose.co.uk securely stores your data at in a Microsoft Office database stored on Microsoft's OneDrive servers.

AsiaChanRose.co.uk will keep your contact information for 2 years. Once this time period has expired, we will delete your data by removing it from the database.

### What are your data protection rights?

AsiaChanRose.co.uk would like to make sure you are fully aware of all of your data protection rights.

Every user is entitled to the following:

- The right to access – You have the right to request AsiaChanRose.co.uk for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification – You have the right to request that AsiaChanRose.co.uk correct any information you believe is inaccurate. You also have the right to request AsiaChanRose.co.uk to complete information you believe is incomplete.
- The right to erasure – You have the right to request that AsiaChanRose.co.uk erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that AsiaChanRose.co.uk restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to AsiaChanRose.co.uk's processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that AsiaChanRose.co.uk transfer your personal data that we have collected to another organization, or directly to you, under certain conditions.
