

ARTICLES OF ASSOCIATION

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, desirous of forming a corporation under the laws of Missouri, and more particularly under the provisions of Article VII, Chapter 90, Revised Statutes of Missouri, 1919, and amendments thereto governing manufacturing and business companies, have entered into the following agreement:

ARTICLE I. The name of the corporation shall be Laugh O Gram Films, Inc.

ARTICLE II. The corporation shall be located in Kansas City, Missouri.

ARTICLE III. The amount of capital stock is Fifteen Thousand (\$15,000.00) Dollars, divided into Three Hundred (300) shares of the par value of Fifty (\$50.00) Dollars each; that Fifty-one Per Cent of same has been bona fide subscribed and actually paid up in lawful money of the United States, and in property of the full value of Seven Thousand Seven Hundred (\$7700.00) Dollars, and that the same is in the custody of the persons named as the first Board of Directors; that the amount of stock actually paid up in lawful money of the United States is the sum of Two Thousand Seven Hundred (\$2700.00) Dollars, and that Five Thousand (\$5000.00) Dollars of the capital stock has been paid in property, of the full value of Five Thousand (\$5000.00) Dollars, an itemized description of which, with the full cash value thereof, is as follows, to-wit:

ARTICLE VI. That the corporation shall continue for a period of fifty years.

ARTICLE VII. That the corporation is formed for the following purposes, to-wit: To own, make, produce, buy, lease, rent, sell, release, distribute and deal in screen, industrial and commercial advertising and motion pictures of every kind and character; to own, manufacture, buy, lease, rent, sell material and equipment of all kinds used in the making, distributing and exhibiting of motion pictures of all kinds; to own, lease, rent, buy, sell, hold and operate laboratories for the making of motion pictures and screen advertising of all kinds; to exhibit motion pictures; and to own, hold, buy, lease, rent and sell all property, real and personal, and to do all things, necessary and incident to the business aforesaid.
